

## RULES OF PUBLICATION REQUIRED FOR THE DEPOSIT OF THE DOCTORAL THESIS PROGRAMME IN LAW AND ECONOMICS

- a) This activity will be planned and developed in the second or third year for Full-Time Researchers and in the third year or later for Part-Time Researchers, in accordance with the indications of the Thesis Director/Supervisor(s). The Academic Secretary of the Doctoral Programme, Carmen Calderón (calder@ceu.es), will be informed of the publication of this activity and will receive a copy of it so that it can be assessed by the Academic Committee of the Programme.
- b) In order to proceed with the deposit of the thesis, a copy of the publication and a copy of the Commission's resolution approving the thesis must first be submitted.
- c) The author/doctoral candidate/student must state their affiliation in the Law and Economics Programme publication to the International Doctoral School CEINDO. Compliance with this requirement is indispensable and inexcusable for the recognition of any publication. Proposed affiliation:

On the first page of the article or publication, where the name of the doctoral student appears, the following footnote should include: Trainee Researcher of the Law and Economics Programme in the CEU International Doctoral School (CEINDO).

- d) The work to be published must be directly related to the research topic of the thesis, and not correspond to a subject that is not related to the thesis.
- e) As for co-authorship, two areas must be distinguished:
  - In the legal field: the researcher-in-training must appear as the first author of the publication.
  - In the economic field: the researcher-in-training does not need to be listed as the first author.
- f) There is no minimum length required in the publication.
- g) In terms of publication requirements:

## Legal Field

- Indexed Journal, understood as one that is part of "catalogues that assign each journal a relative quality index within the set of journals associated with the same category" (ANECA, 2008).
  - Given the diversity of catalogues that can be consulted for this purpose (JCR, SCOPUS, FECYT, IN-REC, MIAR, CIRC, CARHUSPLUS+, RESH, DICE, LATINDEX, Dialnet, REBIUN...) the journal will be considered to meet the requirements when it conforms to a periodical research publication, which submits the work received to a process of evaluation and accepted by experts. The application of rules for the selection and peer review of the original manuscripts will determine the quality of the journal and its impact factor.
- Book chapter in a reputable publishing house, understood as those works that are published in collective works produced by reputable publishers (catalogued between the first and second quartile), as listed in the Scholarly Publishers' Indicators (SPI) or Book Citation Index (BCI).



## - Economic Field

- Indexed Journal, scientific articles should be published in journals that are classified, at a minimum, in group C of the Integrated Classification of Scientific Journals (ICSR): <a href="https://soporte.dialnet.unirioja.es/portal/es/kb/articles/circ#CIRC">https://soporte.dialnet.unirioja.es/portal/es/kb/articles/circ#CIRC</a> Clasif icacin Integrada de Revistas Cientficas
  Given the relatively long deadlines and the high standards demanded in economics publications, the acceptance by the publisher that the work will be published is acknowledged, even if the actual publication will take place at a later (and perhaps quite lengthy) point in time.
- o Book chapter. Books and chapters of research books must be published by publishers of recognised prestige and with a selective procedure for the acceptance of originals according to systems included in the Scholarly Publishers' Indicators (SPI), and which are in the first quartile for Spanish publishers or in the first and second quartile for international publishers. Similarly, publishers that have obtained the CEA-APQ seal of quality in academic publishing may also be considered. The number and nature of citations received, reviews and criticisms in specialised journals, the collection, translation into other languages, etc. will also be considered.
